
Parent Infant Program-Birth To 3



Summit Speech School's Parent Infant Program supports children with hearing loss from birth to age 3. Teachers of the Deaf provide both remote and home based intervention and parent guidance.

Sound Beginnings toddler groups allow children to meet peers on a weekly basis while their caregivers participate in Family Training support groups. Parent are also welcome to join remotely.

The Parent Infant Program serviced more than 90 babies and their families this year.






Held remotely and in the evenings at the school at least four times a year, connecting parents of children with hearing loss all over New Jersey.




Summit Speech School Financial Highlights

2021 - 2022 Revenues


