Our History...

In 1967 two of the most popular songs on the radio were “I’m a Believer” by The Monkees and “All You Need Is Love” by The Beatles. No doubt, 1967 was a great year to open the doors of Summit Speech School! When our doors opened, so too did limitless possibilities for children with hearing loss.



Originally located at 34 Upper Overlook Road Summit, NJ, Summit Speech School moved to our current location, 705 Central Ave in New Providence, NJ in 1994.

Our Approach and Leadership in the Listening and Spoken Language Community

Listening and Spoken Language is an evidenced-based approach to teaching children how to listen and talk. Our program, since it was founded in 1967, has used only this methodology. Results from the Longitudinal Outcomes of Children With Hearing Loss (LOCHI) study found that *“communicating through LSL alone resulted in higher outcomes when compared to children who used sign language along with LSL”* (Mission Probable, Hearing First; 2019). **Summit Speech School was the first school in the state of New Jersey to use LSL and we remain the only non-profit in New Jersey to operate a private preschool program exclusively using a Listening and Spoken Language approach...** when families decide to use LSL to teach their child to listen and speak, Summit Speech School provides the pathway to limitless opportunities. *As leaders in the LSL community, our professional affiliations include many leading universities, cochlear implant centers and more:*

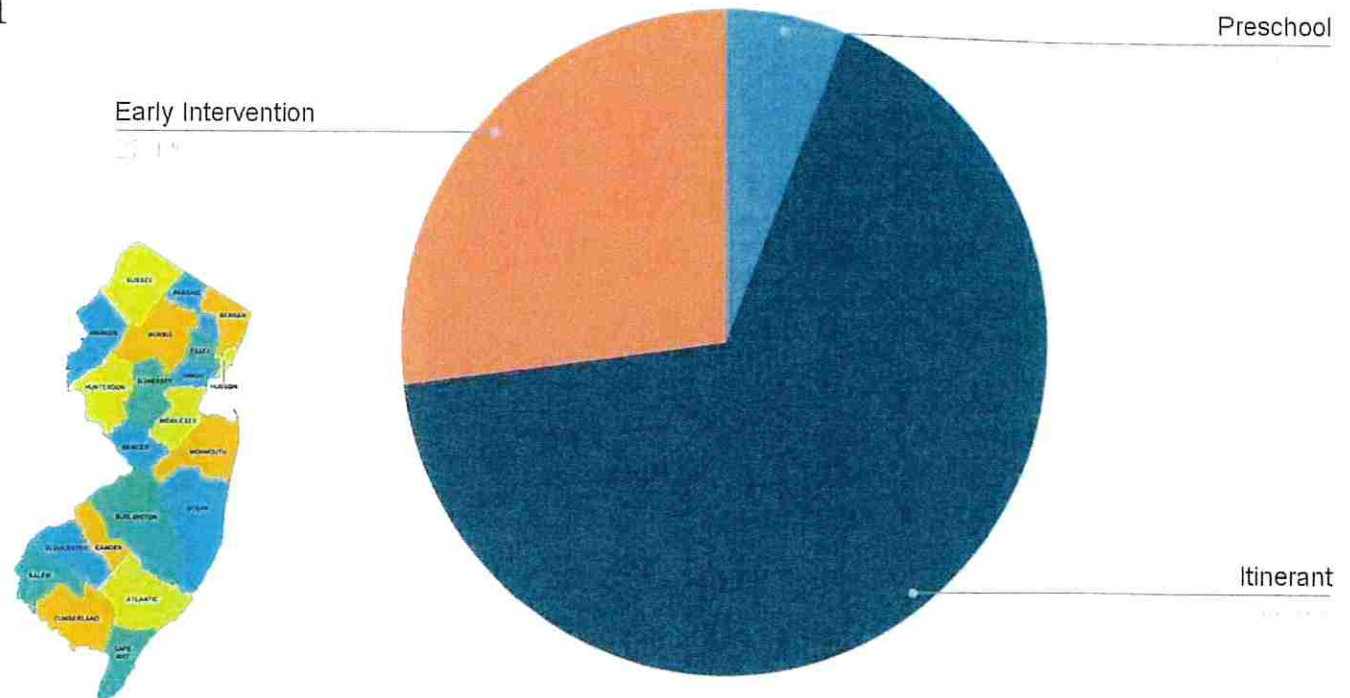

Summit Speech School Children Served by Program



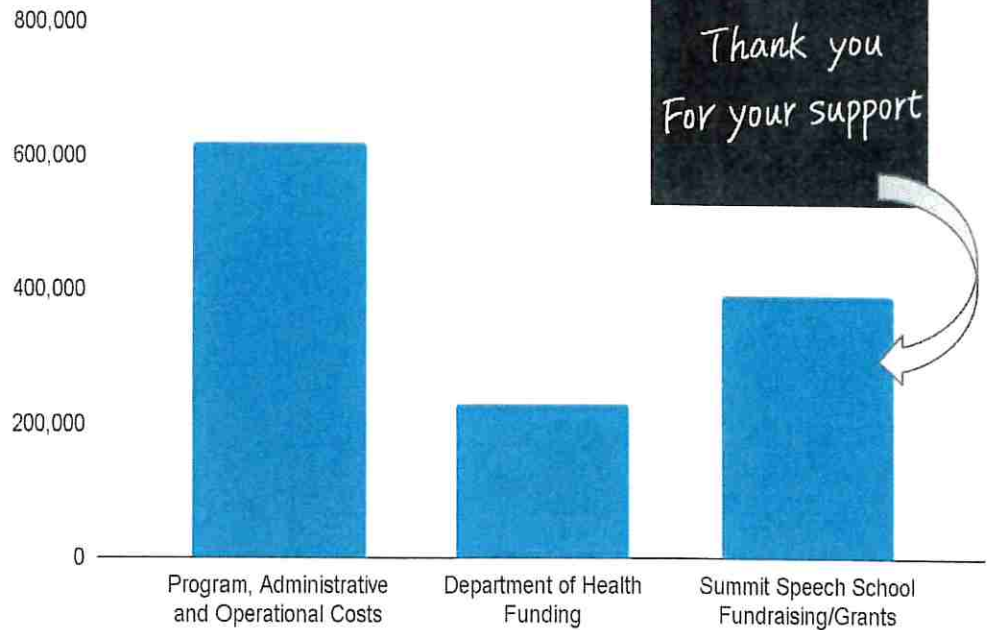
Early Intervention

During the 2022-2023 Fiscal Year, our staff included three full-time Teachers of the Deaf/Hard of Hearing, a full-time interpreter and a part time Teacher of the Deaf and a Speech and Language Pathologist. The cost of the Early Intervention services we provide is only partially funded by the NJ Department of Health.

We rely on our supporters to provide the additional funding, nearly \$400,000, to operate our intensive, impactful and life-changing Parent Infant Program.

Early Intervention: Our Dynamic Parent Infant Program

In addition to providing direct services in the homes of the families we serve, we are also proud to host our Parent Infant Program twice a week throughout the year. Infants as young as six months of age and toddlers up to age three come to Summit Speech School and learn how to talk and listen.

Our multidisciplinary model allows for one of our Teachers of the Deaf/Hard of Hearing, Speech and Language Pathologists and an Occupational Therapist to work as a team, directly with our infants and toddlers. Parents/caregivers learn how to model spoken language skills for children. During other sessions, parents receive training while their children work directly with our staff.

The program provides parents with support and they quickly learn that their child's future, just like any other child, is filled with limitless possibilities!

Preschool: Program Overview

Our 210 day program includes a 30 day extended school year program

Students have daily access to our Educational Audiologist

We are an Approved Private School by the NJ Department of Education

State of the Art Facility: All classrooms and therapy rooms are acoustically treated, have universal access to DM systems and have observation booths with one way access.

Our average class size is 5-7 students

Our staff to student ratio is less than 3:1; staff includes the following:

- 4 Teachers, Dual NJ DOE Certified as a Teacher of the Deaf/Hard of Hearing and Preschool Teacher
- 3.5 Speech and Language Pathologists providing daily speech and language services to every student!
- At least one paraprofessional in each of our 4 classrooms
- All staff receive ongoing training and have expertise in the delivery of Listening and Spoken Language Services
- We have a Full-time Nurse and provide Occupational/Physical Therapy Services

Amazing Impact: 7 out of 7 of our preschool graduates returned to their home school district!





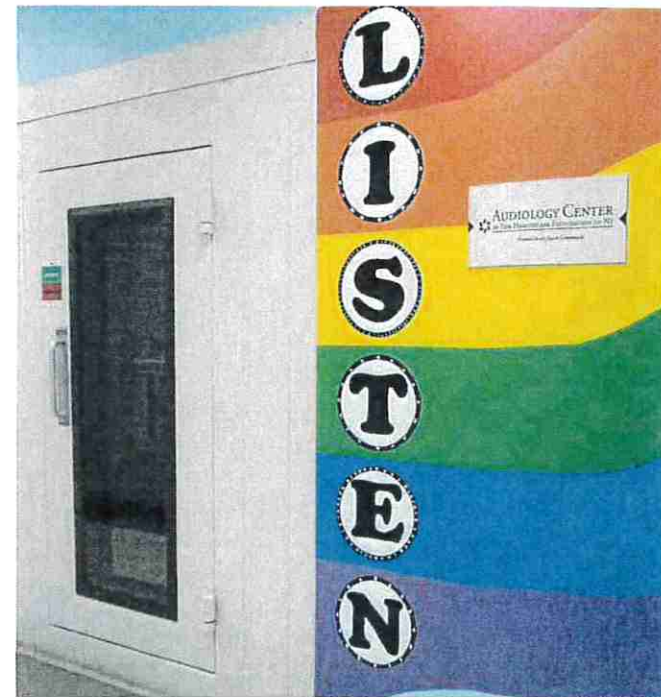
Audiology Services

Our audiology services are critical for the development of listening and language. It is imperative that we ensure every student has access to hearing. When this occurs, we maximize positive outcomes.

Our *professional Audiology Booth* is used to ensure students have access to hearing. Our audiologist uses the booth to check equipment and complete comprehensive evaluations.

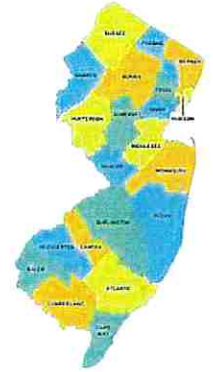
Our audiologist works closely with our Teachers of the Deaf and Speech and Language Pathologists. Additionally, she works closely with each child's clinical audiologist.

We also provide support to school districts, complete private evaluations and provide professional development.





Itinerant Services



As strong proponents of inclusive education, during the 2022-2023 school year we provided services to 242 students in 66 NJ School Districts!

Our Teachers of the Deaf understand the neuroscience of hearing and the scaffolds required for a student to increase Listening and Spoken Language competencies. To optimize a student's access to sound, our Teachers of the Deaf work with students and district staff to improve:

- Auditory Attention Detection
- Memory Discrimination
- Auditory Recognition, Sequencing and Comprehension
- Auditory Retrieval and Expressive Communication

As a result, students are able to remain in their home school district and thrive.

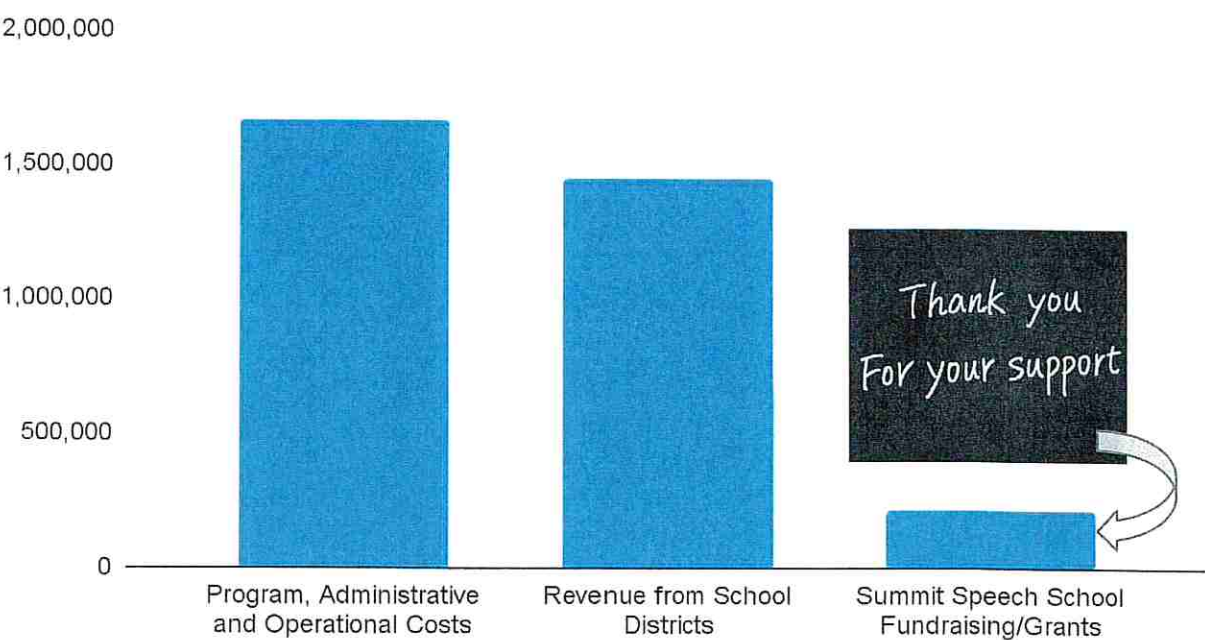
Itinerant Financial Data

During the Fiscal Year 2022-2023, our staff included 12 full-time and 3 part-time Teachers of the Deaf/Hard of Hearing. Local school districts contract with Summit Speech School to provide Listening and Spoken Language services in the student’s home school district.

We rely on our supporters to provide the additional funding, \$215,920, to serve students in their home school district.

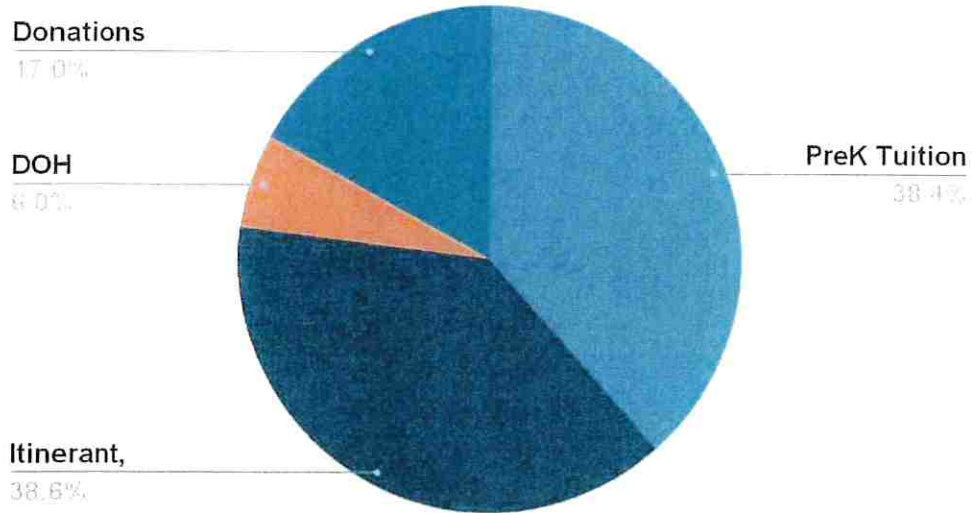


Summit Speech School Revenue and Expenses

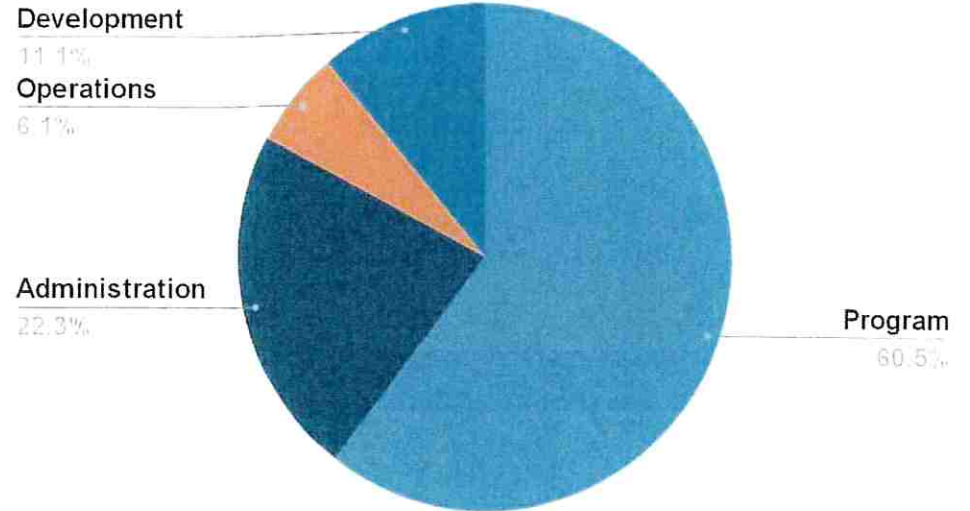

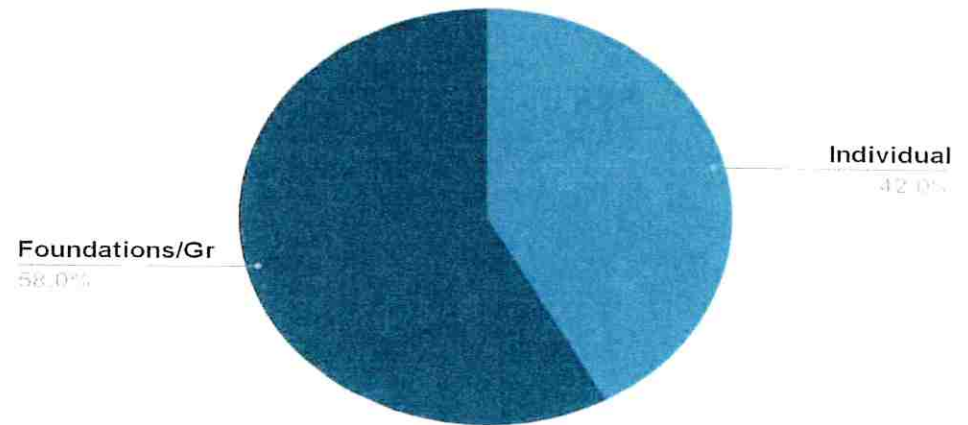

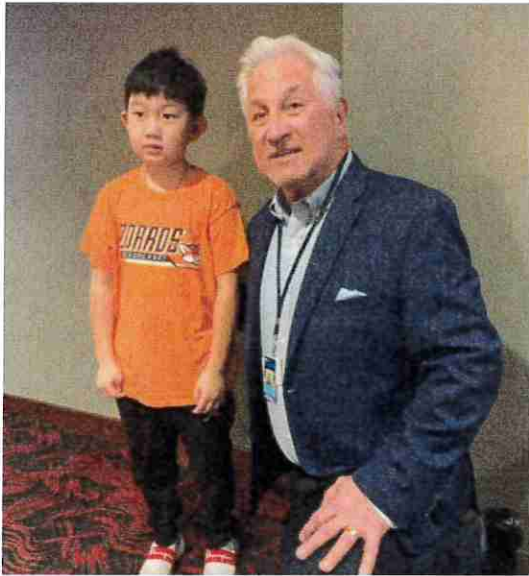
