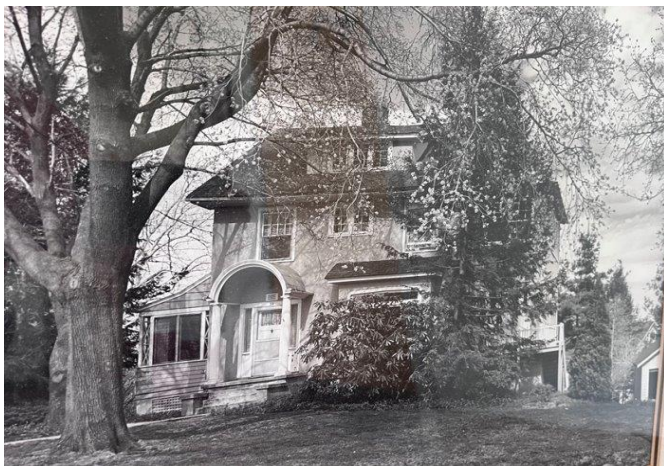

Our History...

In 1967 Summit Speech School opened its doors offering specialized listening and spoken language services to children with hearing loss.

Our Approach and Leadership in the Listening and Spoken Language Community

Listening and Spoken Language (LSL) is an evidenced-based approach to teaching children how to listen and talk. Our school, since it was founded in 1967, has used only this methodology. Results from the Longitudinal Outcomes of Children With Hearing Loss (LOCHI) study found that *“communicating through LSL alone resulted in higher outcomes when compared to children who used sign language along with LSL”* (Mission Probable, Hearing First; 2019).

Summit Speech School was the first school in the state of New Jersey to use LSL and we remain the only non-profit school in New Jersey to operate a private preschool program exclusively using an LSL approach. When families decide to use LSL to teach their child to listen and speak, Summit Speech School helps to provide the pathway to limitless opportunities.

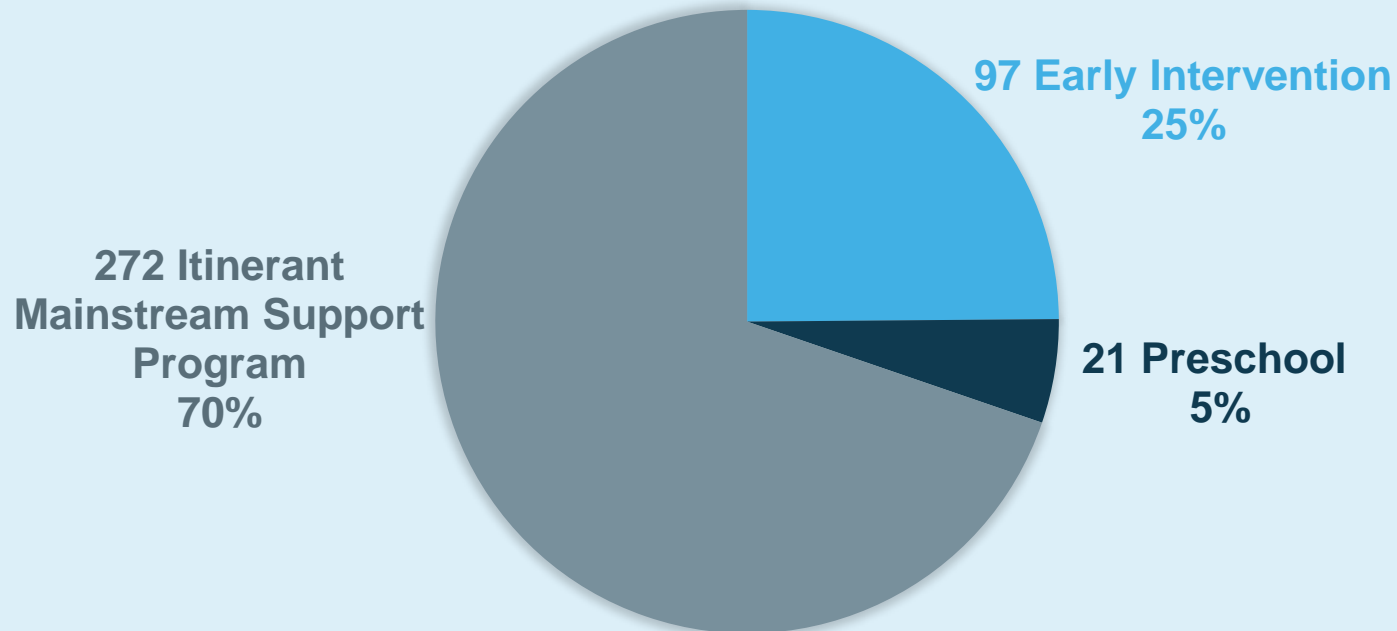

Early Intervention Program: Our Dynamic Parent Infant Program

Parent Support and Education is provided to families free of charge. These sessions occur weekly throughout the year at Summit Speech School. Infants and toddlers up to age three are eligible to attend, supplementing their individual sessions.

Our multidisciplinary model allows for our Teachers of the Deaf/Hard of Hearing, Speech and Language Pathologists, and Occupational Therapist to work as a team, directly with our infants and toddlers. Parents and caregivers learn how to model spoken language skills for their children.

Preschool: At a Glance



- Approved Private School by the NJ Department of Education
- 210-day program includes a 30-day extended school year program
- State of the Art Facility: acoustically treated classrooms and therapy rooms with universal access to DM systems. Observation booths with one way access.
- Students have daily access to Educational Audiologist
- Average class size is 5-7 students
- Staff to student ratio is less than 3:1; staff includes:
 - 4 Teachers, Dual NJ DOE Certified as a Teacher of the Deaf/Hard of Hearing and Preschool Teacher
 - 3 Speech and Language Pathologists providing daily speech and language services to every student
 - 1-3 paraprofessionals in each of our 4 classrooms
 - All staff have expertise in the delivery of Listening and Spoken Language Services as well as receive ongoing training and professional development
 - Full-time Nurse
 - Occupational/Physical Therapy Services

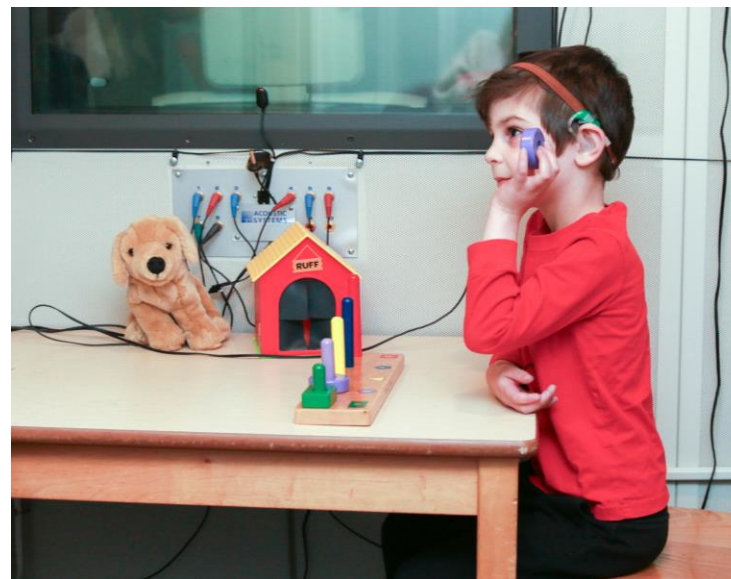
Audiology

Summit Speech School's audiological services play a key role in the development of listening and spoken language for students. It is imperative that we ensure every student has access to sound. When this occurs, positive outcomes for students are maximized.

A highly-equipped audiology booth is used to ensure students have access to sound. We have a full-time audiologist who is able to check individual student's hearing technology and complete comprehensive evaluations.

The School's audiologist works closely with our Teachers of the Deaf and Speech and Language Pathologists as well as each child's clinical audiologist.

Support to school districts, complete private evaluations, and professional development for other professionals is also available.



Attendees at our 3rd Annual Golf Outing generously donated \$52,000 to help fund new “State of the Art” audiology equipment.

Itinerant Mainstream Support Services

During the Fiscal Year 2023-2024, program staff included 11 full-time and 4 part-time Teachers of the Deaf/Hard of Hearing. Local school districts contract with Summit Speech School to provide Listening and Spoken Language services in the student's home school district.

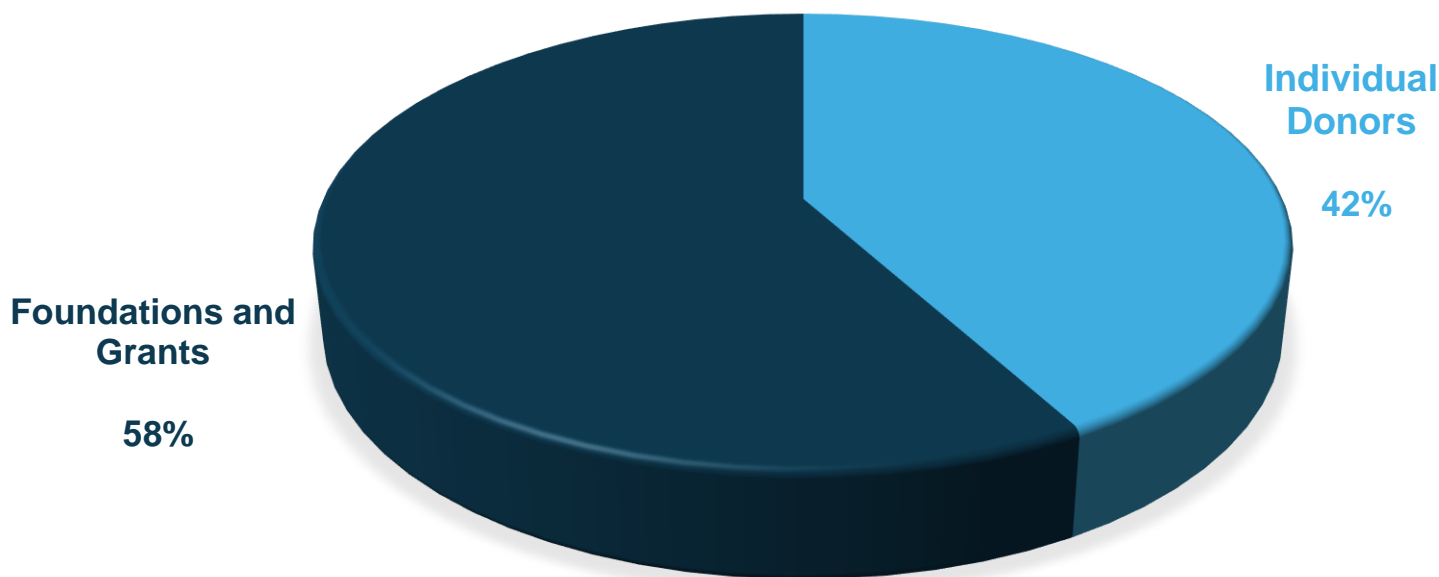
